Journals

Our journal portfolio continues to develop, and we have much to be proud of. This year we launched *European Social Work Research* and announced the *Journal of Global Ageing*, bringing our list to 21 titles. Many of our journals are interdisciplinary and aim to encourage debate across academic silos. As our list grows, we have become particularly strong in the fields of Sociology, Political Science and Social Policy.

We're also delighted that nine of our journals got their first ever Impact Factors in the 2023 Journal Citation Reports. Our oldest journal, *Policy & Politics*, performed especially well, ranking in the top quartile for both Political Science and Public Administration.

In June 2023, we celebrated the first anniversary of *Global Social Challenges Journal* (GSCJ), our first fully Open Access title. This not-for-profit and mission-driven journal publishes work that addresses urgent global social issues across disciplines, fields and geographies. We were pleased to hear that *GSCJ* was accepted into the Directory of Open Access Journals earlier this year.

Following a successful pilot with JISC, we are now offering our Read and Publish agreement to institutions and consortia worldwide. Aimed at being as equitable a route to Open Access as possible with uncapped publishing and affordable, straightforward pricing, the offer has proven popular with the library community.
