The sociology of emotions has developed unique perspectives on emotions that attend to their social construction and the ways in which they are embedded in social structures and inhere in social processes. The Journal seeks to expand the largely unexhausted potential for developing innovative approaches not only to emotions per se, but to the social generally. All methodological approaches to studying emotions are welcome, but they should demonstrate rigour and be framed in ways that will be of interest to sociologically inclined scholars.
